Information on personal data processing for customers/contracting parties of UNIA Sp. z o.o.

1. We would like to inform you that the Personal Data Controller of your personal data is Unia Sp. z o.o. with its registered office in Grudziądz (86-300) ul. 2. Your personal data will be processed for the purposes of making or performing the agreement with Unia Sp. z o.o. The legal basis for its processing is the necessity of data processing in order to perform the agreement, i.e. in accordance with the provisions of Article 6, section, 1 item b of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, GDPR).
3. Additionally, your personal data may be processed in connection with the obligations imposed on Unia Sp. z o.o. by law, e.g. by the Tax Ordinance Act. The legal basis for data processing in this respect is the necessity of the processing in order to comply with the legal obligation of the controller pursuant to Article 6, section 1, item c of the GDPR.

In such a case, the legal basis for the processing of personal data shall be the necessity of the processing in order to fulfil the legitimate interest of the data controller, in accordance with Article 6, section 1, item f of the GDPR.
